E-LEARNING IN SHANGHAI

For the double degree program "International Economics and Trade" of the HAW Hamburg and the University of Shanghai for Science and Technology (USST, China), the Department of Business at the HAW Hamburg would usually send out two lecturers to Shanghai to teach in a classroom setting. Building on the success of two pilot e-learning modules from the summer semester, two further e-learning lectures were developed and successfully implemented. This way, all 48 students were able to participate in the modules "Operations Research", held by Prof. Thomas Bradtke, and "Business Informatics", held by lanina Apostolou and lan-Hendrik Schuenemann, and remain on track with the studies, despite the ongoing travel restrictions. The great participation by our Chinese students makes us optimistic, to include these flexible and innovative methods in the regular curriculum in the post-COVID era.

For a second time this year, the GAIW, a collaborative workshop between the Business departments of the HAW Hamburg and the California Stat University Long Beach (CSULB, USA), took place in an entirely online format. 35 students from both schools participated under the academic supervision of Prof. Natalia Ribberink (HAW) and Prof. Mark Washburn (CSULB) from 15th October until 8th December to work together on a topic that was as current as it gets: *"Sources of competitive advantage in the digital economy"*.

The workshop was once again supported by a wide array of company representatives, who formulated research assignments for student teams from their corporate perspective and guided teams throughout the workshop. Thanks to rigorous hygiene concepts on campus and in the whole city of Lisbon, the lectures could be held securely and with a small number of students in attendance. All lectures with topics like "Internationalisation strategies of SMEs", "Supply Chain Management", and "Port Competitiveness" were not exclusive to the students present on campus, but open to a much larger number of students which checked in via online video calls. "A lively discussion with students arose in every lecture, in which they actively participated. DAAD EXTERNAL FUND APPLICATION

We are proud to announce to be part of a successful HAW.international grant application by the German Academic Exchange Service (DAAD). As one of 31 model projects from all over Germany, the HAW Hamburg has secured funds of 500.000 Euro to about further extend international activities for the upcoming two years. Research and the internationalisation of lectures and students are the main focus of measures under the project. As part of the project, the Department of Business under the lead of Prof. Ribberink, promotes the internationalisation through cooperative research days with the Higher School of Economics (Moscow, Russia). The results of previous cooperation between the two schools resulted in excellent academic output which was presented at international conferences and published. With the help of the successful application, funds to increase these efforts are available to increase the supply of international lectures and extend the share of internationally experienced lecturers and students.
